In the reference cited 1<sup>st</sup>, the school was granted No Objection Certificate for its affiliation of Secondary Syllabus with the Central Board of Secondary Education. ..2..

2. In the reference cited 2<sup>nd</sup>, under the provisions of Right of Children to Free and Compulsory Education Act 2009, Sec 18, read as follows:-

"No School, other than a school established, owned or controlled by the appropriate Government or the local authority, shall, after the commencement of this Act, be established or function, without obtaining a certificate of recognition from such authority, by making an application in such form and manner, as may be prescribed."

3. In the reference cited 3<sup>rd</sup>, the Government issued G.O vide G.O.(Ms) No.144, School Education (GE) Department dated 18.09.2014 making it mandatory for Schools affiliated to boards other than Secondary / Higher Secondary Boards of the State Government to get necessary recognition from the Director of School Education.

With reference to your application dated: 08.02.2021\_and School Inspection in this regard, 1 hereby convey the grant of recognition to the (OM SADHANA CENTRAL SCHOOL, Theni Main Road, T.P.M Nagar, Virattipathu, Madurai District - 625 016) (Survey.No.67/4, 67/5, 67/7B, 67/10 & 67/9) for Classes LKG to XII or the period from 24.05.2021 to 23.05.2024.

The recognition Code Number allotted to your school 004 - 13-S-0006-0524.

The UDISE Code Number 33241119615.

The above recognition is subject to the following conditions:-

- The temporary recognition accorded to the school is valid upto 23.05.2024 and is to be (1)renewed at an interval of every three years.
  - The grant of recognition is not extendable and does not in any way imply any obligation to

recognize-beyond class XII. (2)

- The School shall abide by the provisions of the Right of Children to Free and Compulsory (3) Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.
- The School shall admit in pre-school / class I to the extent of 25% of the strength in each class, (4) children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
- The School shall maintain a separate bank account for the purpose of reimbursement. (5)
- The School shall not collect any capitation fee and subject the child or his or her parent or (6) guardian to any screening procedure.
- The School shall not deny admission to any child, -**(7)** 
  - (a) For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
  - (b) On the ground of religion, caste or race, place of birth or any of them.
- The School shall ensure that,-(8)
- no child admitted shall be held back in any class or expelled from School till the completion of (i) elementary education in a school;
- no child shall be subjected to physical punishment or mental harassment. (ii)
- no child is required to pass any board examination till the completion of elementary education; (iii)
- every child completing elementary education shall be awarded a certificate as laid down under (iv) rule 21.
- inclusion of students with disabilities / special needs as per provision of the Act. (v)
- the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act: (vi) Provided that the teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
- the teacher performs his duties specified under sub-section (1) of section 24 of the Act; and (vii)
- the teacher shall not engage himself for private teaching activities. (viii)

- The School shall follow the basic requirements and syllabus on the basis of curriculum laid (9) down by Appropriate authority.
- The School shall maintain the standards and norms as specified in section 19 of the Act (10)
- No unrecognized classes shall run within the premises of the school or outside in the name of (11)
- The school building or other structures and the grounds are used only for the (12)of education and skill development.
- The School is run by a society registered under the Tamil Nadu Societies Registration Act, (13)1975 (Tamil Nadu Act 27 of 1975), or a public trust constituted under any law for the time being in force;
- School is not run for profit to any individual, group or association The (14)individuals or any other persons;
- The accounts should be audited and certified by a Chartered Accountant and (15)accounts statements should be prepared. A copy each of the Statements of Accounts should be sent every year to the competent Authority granting recognition.
- The recognition Code Number shall be quoted for any correspondence with the competent (16)authority.
- The School shall furnish such reports and information as may be required by the competent (17)authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the School;

B.(1) Tamil shall be taught as a subject from in Standards I to IX in all schools notified under sub clause (iv) of clause (e) of section 2 of the Tamil Nadu Tamil Learning Act, 2006 (Tamil Nadu Act 13 of 2006) in a phased manner commencing from the Academic year 2015-2016 for standard I, from the academic year 2016-2017 for standard I and II and shall be extended up to standard IX in a like manner as ordered in a reference (4) cited.

- Sanitary and Hygiene Certificate issued by the Health Officer of the locality and; (iii)
- No Objection Certificate obtained from the Station Officer (Fire and Rescue)in the area, (iv) where the School is situated;
